INFORMED CONSENT *for permanent makeup*

You confirm that you are over the age of 18, and are not under the influence of drugs or alcohol, am not pregnant or nursing and desire to receive the indicated procedure.

If an unforeseen condition arises in the course of the procedure, You authorize my therapist to use his/her professional judgment to decide what he/she feels is necessary under the given circumstances. You accept the responsibility for determining the color, shape and position of the Permanent Makeup procedure as agreed during consultation. You fully understand and accept that non-toxic pigments are used during the procedure and that the result achieved may fade over a period of 1-3 years. Even once the color fades, pigment itself may stay in the skin indefinitely.

You have been informed that the highest standards of hygiene are met and that sterile, disposable needles and pigment containers are used for each individual client, procedure and visit.

You understand and accept that each procedure is a process requiring multiple applications of pigment to achieve desired results and that 100% success cannot be guaranteed during the first procedure. You understand that you may have to return for a repeat procedure.

The result of the procedure can be affected by the following: medication, skin characteristics (dry, oily, sun-damaged thick or thin skin type), personal pH balance of your skin, alcohol intake and smoking, post procedure after care.

Upon completion of the procedure there might be swelling and redness of the skin, which will subside within 1-4 days. In some cases, bruising may occur. You may resume normal activities following the procedure, however, using cosmetics, excessive perspiration and exposure to the sun should be limited until the skin has fully healed. Please see after care instructions for more details. The procedure results will look acceptable for you to appear in public without additional make-up.

You have been advised that the true color will be seen 6-8 weeks after each procedure, and that the pigment may vary according to skin tones, skin type, age and skin condition. You understand that some skin types accept pigment more readily and no guarantee on exact color can be given.

To your knowledge, You do not have any physical, mental or medical impairment or disability that might affect my well being as a direct or indirect result of my decision to have the procedure done at this time.

You agree to follow all pre-procedure and post-procedure instructions as provided and explained to me by the technician. Failure to do so may jeopardise my chances for a successful procedure.

You certify that you have read and fully understand the above paragraphs, that you have had sufficient opportunity for discussion and to ask questions, and you release this skin care professional from liability and assume full responsibility thereof, that you hereby consent to the procedure described above.

INFORMED CONSENT CONTINUED

You have been informed of the nature, risks, and possible complications and consequences of permanent skin pigmentation, Lip Blush, Brow Lamination & Tint and Lash Lamination & Tint. You understand the permanent skin pigmentation, lip blush, lash lamination & tint and lash lamination and tint, procedures carries with it known and unknown complications and consequences associated with this type of cosmetic procedure, including but not limited to: infection, scarring, inconsistent color, and spreading, fanning or fading of pigments. You understand the actual color of the pigment may be modified slightly, due to the tone and color of your skin.

You fully understand this is a tattoo process and therefore not an exact science but an art. You request the semi- permanent procedure(s) and accept the permanence of this procedure as well as the possible complications and consequences of the said procedure(s).

There is a possibility of an allergic reaction to numbing agent and/or pigments. A patch test is offered however it does not ensure a client will not have an allergic reaction. If waived, you release the technician from liability if you develop an allergic reaction to the pigment.

You understand that if you have any skin treatments, injectables, laser hair removal, plastic surgery or other skin altering procedures, it may result in adverse changes to my permanent makeup procedure. You acknowledge some of these potential adverse changes may not be correctable.

You certify that you have read and initialed the above paragraphs and have had explained to my understanding the consent and procedure permit. You accept full responsibility for the decision to have this cosmetic semi-permanent pigmentation work done.

You hereby consent to and authorize my Cosmetic Professional to perform the following procedure(s):

PMU BROWS PRE-PROCEDURE

What To Expect On The Day of Procedure:

When you arrive at your appointment, a brow map will be customized by a series of horizontal, vertical, and diagonal lines, based on your skin's proportions and drawn on with an oil-based crayon, thus, framing the area within which hair-like strokes, shading, and/or a combination of both will be micro-pigmented/tattooed into the dermis of the skin. (See for For Either Procedure)

Consultation:

You will have a consultation with your permanent makeup artist to discuss your desired brow shape and color. The artist will also examine your skin type and discuss any allergies or medical conditions you may have.

Numbing:

During the procedure, a topical numbing cream will be applied to the brow area to minimize discomfort during the procedure.

Mapping:

The artist will use a crayon to outline the shape of your new brows, taking into account your natural brow shape and facial features.

Pigment application:

Using a handheld device with a small needle, the artist will apply pigment to the skin in small dotted manner, to create a natural-looking brow shape.

Procedure:

Typically takes between 1-2 hours to complete, depending on the complexity of the brow shape and the amount of pigment needed. It is important to follow the aftercare instructions carefully to ensure proper healing and optimal results

You have read and fully understood the above information regarding the process of the procedure to be received. You certify that you have had sufficient opportunity for discussion and to ask questions, and that You hereby consent to the procedure(s) described above.

PMU LIP BLUSH PRE - PROCEDURE *information & advice*

What To Expect On The Day of Procedure:

When you arrive at your appointment, a lip map will be customised by a series of horizontal, vertical, and diagonal lines, based on your skin's proportions and drawn on with an oil-based crayon, thus, framing the area within shading, and will be micro-pigmented/tattooed into the dermis of the lip skin.

Consultation:

You will have a consultation with your permanent makeup artist to discuss your desired Lip shape and color. The artist will also examine your skin type and discuss any allergies or medical conditions you may have.

Numbing:

Numbing is not recommended during the procedure as it interferes with the process and can make it harder to insert the pigment. However it can be offered if there is discomfort.

Mapping:

The artist will moisturise the lip area, then use a crayon to outline the shape of your new lips, taking into account your natural lip shape and facial features if need be. In some cases mapping is not needed eg: during lip neutralisation process

Pigment application:

Using a handheld device with a small needle, the artist will apply pigment to the skin in small dotted manner, to create a natural-looking lip shape/colour.

Procedure:

Typically takes between 2-3 hours to complete, depending on the complexity of the lip shape and the amount of pigment needed. It is important to follow the aftercare instructions carefully to ensure proper healing and optimal results

You have read and fully understood the above information regarding the process of the procedure to be received. You certify that you have had sufficient opportunity for discussion and to ask questions, and that You hereby consent to the procedure(s) described above.

LASH LIFT AND TINT PRE - PROCEDURE *information & advice*

What To Expect On The Day of Procedure:

When you arrive at your appointment, your lashes will be examined to see if they are for for the procedure and cleansed prior to any application.

Consultation:

You will have a consultation with your makeup artist to discuss your desired curl and color. The artist will also examine your skin type and discuss any allergies or medical conditions you may have.

Mapping:

The artist will use a silicon on top of your eye lid , taking into account your natural lash length and facial features.

Pigment application:

The artist will clean the skin in the eyelashes, apply perm solution, neutraliser and then pigment to the skin i\, to create a natural-looking lash lift shape and colour

Procedure:

Typically takes between 45 mins to an hours to complete, depending on the complexity of the lash shape and the amount of pigment needed. It is important to follow the aftercare instructions carefully to ensure proper healing and optimal results

You have read and fully understood the above information regarding the process of the procedure to be received. You certify that you have had sufficient opportunity for discussion and to ask questions, and that You hereby consent to the procedure(s) described above.

BROW LAMINATION & TINT PRE – PROCEDURE *information & advice*

What To Expect On The Day of Procedure:

When you arrive at your appointment, a brow map will be customized by a series of horizontal, vertical, and diagonal lines, based on your skin's proportions and drawn on with an oil-based crayon, thus, framing the area within shading,

Consultation:

You will have a consultation with your makeup artist to discuss your desired brow shape and color. The artist will also examine your skin type and discuss any allergies or medical conditions you may have.

Mapping:

The artist will use a crayon to outline the shape of your new eyebrows, taking into account your natural brow shape and facial features.

Pigment application:

The artist will clean the brows, apply perm solution, neutraliser and then pigment to the skin, to create a natural-looking brow lift, shape and colour

Procedure:

Typically takes between 45 mins to an hours to complete, depending on the complexity of the brow shape and the amount of pigment needed. It is important to follow the aftercare instructions carefully to ensure proper healing and optimal results

You have read and fully understood the above information regarding the process of the procedure to be received. You certify that you have had sufficient opportunity for discussion and to ask questions, and that You hereby consent to the procedure(s) described above.

The customer acknowledges that this release is given with the express intention of effecting the extinguishment of certain obligations owed to the customer, and with the intention of binding the customers spouse, heirs, executors, administrators, legal representatives and assigns.

Both the customer and "Brow & Blink Limited" to this Agreement agree and accept not to make any claim(s) or take proceedings against any other person or corporation which might claim contribution or indemnity under the provisions of any statute or otherwise.

The customer agrees and accepts to not defame the brand or the persons(s) involved in "Brow & Blink Limited", including but not limited to on the internet, social media, through word of mouth or a false review, by doing so the customer agrees and accepts that "Brow & Blink Limited" may be subject to compensation or claim against the customer.

If the customer doesn't come for the touch-up appointment between the date of the first appointment and post eight weeks of the initial appointment, then the customer will be charged as a new client.

The customer agrees that this treatment may not deliver their desired results and can be affected by things such as the shape of the customers eye-bones, nose bridge, eyebrow symmetry, scars, previous tattoo that may have been done prior by another artist (**This must be disclosed prior to treatment**), and or any medication the customer may be taking. The treatment can also be affected by the customers choice of the brow shape, having gone against the beauticians advice, which is out of the beauticians control.

The customer agrees and accepts that giving misinformation or false information may result in the treatment being stopped immediately and any payment made shall not be refunded.

You certify that you have read and fully understand the above paragraphs, that you have had sufficient opportunity for discussion and to ask questions, and that you hereby consent to the information described above. You also release this beautician from liability and assume full responsibility thereof.

IMPORTANT INFORMATION

If you are currently using or have used Roaccutane you must wait at least one year before considering this treatment.

If you use RETIN-A or antibiotics, high doses of anti-inflammatory medications or topical medical creams we cannot do any type of cosmetic tattooing on you until 6 months after you have stopped using these drugs. (This also includes any products you may be using that contain Vitamin A or C)

Some antibiotics and anti-inflammatory drugs can delay the healing process and cause skin to reject the pigmentation. Please let me know **BEFORE** your treatment date as we may need to be cancel or postpone your appointment.

This treatment is not ideal for everyone, so please read this carefully and if you have any questions, please feel free to ask.

Semi-permanent make-up is NOT recommended for any clients who are or have:

Pregnant or nursing

Diabetic

Undergoing Chemotherapy (consult your doctor)

Viral infections and/or diseases

Epilepsy

A Pacemaker or major heart problems

Had an Organ transplant

Skin irritations or Psoriasis near the treated area (rashes, sunburn, acne, etc.)

Prone to Keloids

Are Sick (cold, flu, etc.)

Treatment Preparation

Shower the morning of or the night before your appointment making sure to wash your hair as you can not get your Brows wet for at least 6 hours after the treatment for Lip Blush and Powder Brows.

Do not wear make up to your appointment.

Discontinue use of AHA (chemical exfoliation) skin care products close to the brow & Lip area at least one week prior to your procedure.

No laser or electrolysis on or around the treatment area one week prior to the session.

Do not have any chemical peels, dermabrasions, mesotherapy, or any other intense treatments which will cause faster skin cell rejuvenating and cause skin irritation four weeks before procedure.

No Botox or fillers in the procedure area four weeks prior to the procedure.

If you regularly get your eyebrows shaped, waxed, threaded or tinted, please do so at least five days prior to your appointment to allow for the skin to rejuvenate.

It is highly recommended that you avoid SUN and TANNING BED exposure for 30 days BEFORE and AFTER your procedure. If you show up for your appointment with a new tan or a sunburn, you will need to reschedule and will forfeit your session fee, as your skin exfoliates from a sunburn, it will take the pigment with it.

Lash Lift

AFTERCARE

The aftercare for the any lamination or lifting service is so important to maintain a tight lift/curl. If water gets in contact with them within 24 hours the lift/curl will drop. This is because the cuticle hasn't closed yet and the water effectively washes out what has been done.

DAY OF:

- Don't rub or wet your lashes and brows within 24 hours
- Don't apply any products such as makeup, face cream or any conditioning oils
- Be careful taking hot showers or using face steamers or sauna
- Be careful not to sleep on your lashes and brows until they have fully set.

WEEK AFTER:

- Avoid rubbing your eyelashes and brows
- No use of face steamer or sauna
- Don't use oil-based products or conditioners such as castor, coconut, jojoba oil
- Avoid using a waterproof mascara or brow products
- Use gentle foaming facial cleanser
- Use oil-free lash and brow enhancing serum
- Brush your lashes and brows gently to retain the shape

AFTERCARE

The aftercare for the brow and lash services is so important to maintain the colour and desired effect for as long as possible.

- Avoid any water for at least 24hrs - this can fade the results.
- Apply Brow Oil every day to keep hairs hydrated and the skin nourished.
- For the first 24-48 hours keep those follicles squeaky clean - don't touch them with dirty hands!
- Avoid sun, U/V exposure this can fade the end result faster.
- Don't use perfumed products, oils, moisturises or heavy makeup other than those recommended by your Brow Artist.
- Don't use any active skin care or facial treatments. Any active skincare on the brow in between appointments will strip the brow colour/henna.
- If you are maintaining your brows at home with tweezing - if make a mistake, don't try and fix it.
- Leave the trimming to the professionals!

You acknowledge that if you choose the shape of your eyebrow during the session, that the beautician takes no liability for the results, as it may go against the beauticians advice.

You must make sure that 12 hours prior to the session, you must not have any caffeine, alcohol or have smoked. Doing so may result in a cancellati

You agree and understand that under no circumstance shall a refund be given once the procedure has started or finished, and you agree for the beautician to take a before and after photo for record keeping purposes. You also agree and understand the procedures risk(s) involved and that you may not achieve the desired results from the session. You agree and accept to release the beautician and "Brow and Blink Limited" of all liability including loss or damages to yourself as a result of the session or treatment.

PERMANENT MAKEUP PRE -PROCEDURE

information & advice

Permanent makeup procedures normally require multiple treatment sessions. For best results, clients will be required to return for at least a minimum of one finishing session. This will take place 5-7 weeks after the initial procedure. Those with oily skin may require an additional touch up. Please be aware that color intensity will be significantly darker and sharper immediately and a few days after the initial procedure, but the color will typically reduce by 30-60% (More or less).

Although numbing cream/solution is used during the procedure, sensitivity or discomfort may still be felt. Skin may be red, bruised and/or swollen after the procedure.

You acknowledge that you have not consumed alcohol or smoked 12 hours prior to the treatment.

Consulting a medical professional first such as your GP or doctor, You acknowledge that you have not consumed taking things that thin the blood like fish oils, herbals, Vitamin E, aspirins, and/or ibuprofen and do not donate plasma in the 7 days prior to procedure.

You acknowledge that you have not consumed the following prior to your appointment: Black pepper, Cardamom, any member of the Ginger family, Cayenne, Cinnamon, Garlic, Horseradish, Mustard.

A patch test can be performed, unless waived by client. It is the client's responsibility to schedule this at least one week prior to procedure.

Patients prone to cold sores/fever blisters should take an anti-viral prior to treatment. Hormone therapies can affect pigmentation and/or cause sensitivity.

Discontinue use of any brow- or lash-growth serums such as Latisse or RevitaLash, as it can cause sensitivity/affects pigment retention.

Botox, AHA products and retinoids should be avoided for 2 weeks prior to the procedure.

Topical Anesthetic Advice:

Allergic reaction can occur from any anesthetics (lidocaine) used during the procedure. If you do suffer from an allergic reaction, you should contact your doctor immediately. Allergic reaction response may show through redness, swelling, rash, blistering, dryness or any other symptoms associated with an allergic reaction.

Numbness – We cannot accept responsibility if the area to be treated does not respond to the numbing cream. Each individual is different according to skin type. Some clients report the area to be completely numb, while others may experience some discomfort.
